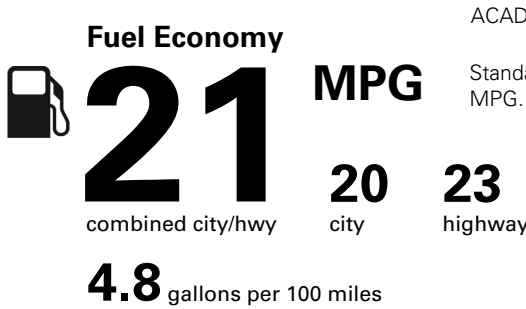

Gasoline Vehicle

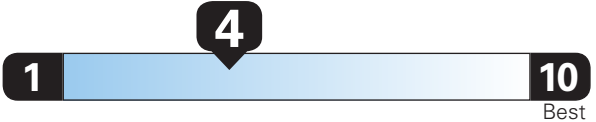
